

 - ≻Several Parties








JCT 2016 - Features

Q: Has anyone read JCT conditions other than section 6 [Insurance]?

The Contract

- Recital The Employer and Contractor agree the proposals
- Articles The Recital broken down into specific detail
- Contract Particulars -'Fill in the boxes'
- Attestation Signing by both parties





Contract Particulars


- Start/Completion Dates
- Named sub-contractors
- Health and Safety
- Liquidated Damages –(if any) expressed usually as an agreed amount per.....
- Rectification/Maintenance Period
- Types/Amounts of Bonds-if any

- Public Liability -levels of Indemnity
- 6.5.1 Liability of the Employer
- Insurance of the Works -Options A, B or C
- Terrorism
- Professional Indemnity -levels of Indemnity
- Third party Rights and Collateral Warranties


